This Document once signed is considered binding.

This document outlines in plain English, general terms of membership at NEWTEC Pistol Club Incorporated. The document does not include all conditions/terms of membership and only operates as a supplement to the NEWTEC Pistol Club Constitution and all other documents.

1. Membership is non-transferrable and NON REFUNDABLE.
2. Annual fees are due by 2 pm on the 14th of September annually, (subject to review by the committee with notice)
Membership expiry is the 30th of September.
 - a. Failure to pay fees by 14th September annually will result in cancellation of membership on 30th September.
 - i. You will be required to re-join the club after 30th September; application is made to the committee and will be resolved at the next committee meeting.
 - ii. You will be Charged a late fee, from 2:01pm 14th September to 11:59pm on the 30th of September.
 - iii. You will be charged a re-join after the 30th of September.
 - iv. The club will reset your joining date you re-joined, you will be re joined as a conditional member if not already in this category.
 - v. The club will also advise the NSW Firearms Registry and NSWAPA immediately that you are unfinancial (no longer a member).
 - b. The club may allow you time to pay club fees upon application, this is to be made prior to 30th August (the club will not have ongoing arrangements).
3. Membership does not guarantee.
 - a. Issuance/approval/renewal/retention of a firearms licence or permits. The club will not refund any portion of fees if you are not issued a licence by the NSW Firearms Registry.
 - b. Range time
 - c. Any personal results or goals in the sport.
 - d. Membership Renewal
4. Membership fees are non-refundable.
 - a. In certain circumstances the club may resolve to refund fees in exceptional circumstances this will be less unrecoverable costs e.g. capitation, administration costs, incidentals, & consumables.
5. Members are required to follow the Firearms Act, Regulations and other legislation relating to firearms in any jurisdiction.
6. Members/Licence holder is required to always maintain up to date information with the club. This is updated via the appropriate form of the day in writing.
7. Members are expected to attend club working bees totally 4 annually, this is recorded, a non-attendance fee will be charged if you do not attend.
8. Firearms licence holders are responsible for the administration of their firearms licence, NEWTEC Pistol Club does not act on behalf of members in licencing issues with external bodies/authorities.
9. New Members will be subject to a probationary period of 24 months, during this time any failures or conduct not befitting will result in you being expelled from the club.
10. NEWTEC Pistol Club Incorporated reserves the right not to renew members if they do not meet the expectations and or values of the club.
11. You will be subject to the terms of the approved constitution of the time while a member of NEWTEC Pistol Club.
12. Members must have a current membership card and firearms licence while on the range or handling firearms.
13. While on ranges members are to conduct themselves appropriately and safely, adhering to standing orders and directions of officials.
14. You must maintain a valid licence, if a licence is suspended, revoked, invalid or anything that results in you not being permitted to hold firearms or a licence you must advise the club within 24 hours of you being made aware of the situation. The club will determine if they should continue membership if the matter extends through a renewal period.
15. Members are to respond to all official correspondence within 7 days. Failure to do so may result in suspension, dependent on what the correspondence relates to.
16. Members are not permitted to access the club ranges outside of operating hours unless approval is given to do so, and no shooting activities will take place outside of operational hours without written consent. Members found to be breaching this will have their membership immediately terminated.
17. Photographs/Videos/Audio recordings while at NEWTEC Pistol Club are strictly prohibited. Persons breaching this will be asked to leave and members will be either suspended or expelled.
18. Documents with the NEWTEC Pistol Club letterhead, or any identifying marks are not to be used, distributed or reproduced without express written consent of the Executive Committee.
19. NEWTEC Pistol Club strictly prohibits posting of NEWTEC information/photos/logo/or any other identifiable information on social media or internet sites in any form. Persons breaching this will be directed to remove such items and action will be taken by the committee against those persons.

2. **YOU WILL ALWAYS** abide by the Club Constitution a copy is available on the Club website.
3. Membership Fees are due Annually by **14th September**, you are responsible to pay on time.
 - a. Notices will be placed in the clubhouse with important information about fees.
 - b. Failure to pay fees/levies/subscriptions by the due date without an approved plan will mean.
 - i. You will no longer be a member of NEWTEC.
 - ii. NSW Firearms Registry and NSWAPA will be notified.
 - iii. Upon application (If accepted) you will be levied re-join fees and your joining date will be the day of payment.

F1 – Newtec Pistol Club Code of Conduct
